**GIST OF THE COMPLAINT:**

The complainant consumer Late Kushadhar Satnami Repr. by Sri Gupteswar Satnami, At/Po-Chichia, Ps- Golamunda, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 20.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- **9043-4229-0118** under SDO elect. Dharamgarh.
- 2) As complained by the complainant that excess units was billed in the month of 08/2016.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/03/2025
- 2) Bill details from: 08/2010 to 02/2025



- 3) Date of supply: 19/08/2010
- 4) Category: LT/Domestic
- 5) Connected Load 1.5 KW
- 6) Meter No – LW218393
- 7) Installed on: 27/02/2019 with IMR "0"
- 8) CMR: 454 KWH on 28/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO elect. Dharamgarh as follows:
  - Billing was actual and 5420 units billed on 08/2016 and meter was installed on 27/02/2019 and billing is actual till now.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Billing was actual and 5420 units billed on 08/2016 and meter was installed on 27/02/2019 and billing is actual till now.
- As per billing database the meter reading for the month of 08/2016 was 150 units but the meter reading for the month of 06/2016 was 4730 units which seems that the meter reading was round completed and 5420 unit was billed for the month of 08/2016 which seems to be suppressed meter reading.

### **ORDER**

**29.03.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast the bill from 08/2010 to 08/2016 by taking IMR "0" kwh on 08/2010 and FMR "10150" kwh (Round Complete) on 08/2016.


The case is disposed of accordingly.
