GIST OF THE COMPLAINT:

The complainant consumer Sri Pustam Bandichhod, Repr. by Sri Lochan Bandichhod, At/Po- Golamunda, Ps- Golamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 22.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9043-4305-0117 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the provisional/average bill was served with high consumptions from 11/2010 to 07/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 06/2011 to 09/2024

4) Category: LT/Domestic

5) Connected Load 1 KW

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Dharamgarh as follows:

The consumer is complaining about bill revision during the average and wrong billing from 11/2020 to 07/2024. A new meter was installed on 04/04/2024 and billing is actual till now.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer is complaining about bill revision during the average and wrong billing from 11/2020 to 07/2024. A new meter was installed on 04/04/2024 and billing is actual till now.
- As per billing database some bill was raised in high consumption from 11/2010 to 02/2024, which seems supress meter reading. And average bill was served from 03/2024 to 06/2024.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 11/2010 to 02/2024 with IMR "0" KwH on 11/2010 and FMR "13861" KwH on 02/2024.
- > To revise the bill from 03/2024 to 06/2024 by taking six-month average consumption of new meter was installed on 04/08/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
