GIST OF THE COMPLAINT:

The complainant consumer Sri Patiram Majhi, AT- Gududuguma, Po/Ps- Golamunda Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9043-4306-0134 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the provisional bill was raised 06/2023 to 09/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

• Billing was average on 08/2024 with 672 units and in previous meter 4189 units billed on 04/2023, 1120 units on 07/2023 and 1221 units on 03/2024. Meter is changed on 22/10/2024 and billing is actual till now.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Billing was average on 08/2024 with 672 units and in previous meter 4189 units billed on 04/2023, 1120 units on 07/2023 and 1221 units on 03/2024. Meter is changed on 22/10/2024 and billing is actual till now.
- As per billing database the provisional/average bill was served from 06/2023 to 09/2024.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 06/2023 to 09/2024 by taking 6 months average consumption of new meter installed on 22.10.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>May-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
