GIST OF THE COMPLAINT:

The complainant consumer Smt. Hastini Tandi, At- Bhataguda, Po- Naktikani, Ps-Golamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant appeared and submitted during course of hearing at camp court at Golamunda on dt. 04.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9043-4306-0836 under Elect. SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the abnormal bill was served in the month of July-2024 and August-2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

Billing was average from 12/2024 to 03/2025. Meter was installed on 16/05/2025 and billing is actual with 0-unit consumption.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Billing was average from 12/2024 to 03/2025. Meter was installed on 16/05/2025 and billing is actual with 0-unit consumption.
- As per billing database the abnormal/average bill was served from 07/2024 to 04/2025.

ORDER 26.06.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 07/2024 to 04/2025 by taking six-month average consumption of new meter installed on 16.05.2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by November-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
