#### GIST OF THE COMPLAINT:

The complainant consumer Sri Giridhari Teli, At- Tumura, Po- Manjhari, Ps-Golamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 22.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.5 KW having consumer no-9043-4309-0533 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant excess bill amount was served in the month of 06/2024 and 09/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

The consumer is complaining about bill revision of previous bill of wrong billing periods from 06/2024 to 09/2024 as 10452 units billed on 06/2024 and 4620 units billed on 09/2024.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer is complaining about bill revision of previous bill of wrong billing periods from 06/2024 to 09/2024 as 10452 units billed on 06/2024 and 4620 units billed on 09/2024.

# ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill for the month of 09/2024 by taking six-month average consumption of new meter install on 01/10/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
