#### GIST OF THE COMPLAINT:

The complainant consumer Sri Ugrasen Aghria, Repr. by Sri Humansu Aghria, At/Po-Manjhari, Ps- Golamunda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 22.10.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.5 KW having consumer no-9043-4311-0672 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that some bill was raised in high consumption from 07/2018 to 12/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Dharamgarh as follows:

The consumer is complaining about bill revision of wrong billing periods from 07/2018 to 12/2023 as 5121 units billed on 05/2023. The billing is actual till now.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer is complaining about bill revision of wrong billing periods from 07/2018 to 12/2023 as 5121 units billed on 05/2023. The billing is actual till now.
- As per billing database some bill was raised in high consumption from 07/2018 to 06/2023, which seems supress meter reading. And the bill was raised in average basis from 07/2023 to 12/2023.

# **ORDER** 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 07/2018 to 06/2023 with IMR "0" KwH on 07/2018 and FMR "7022" KwH on 06/2023.
- To revise the bill from 07/2023 to 12/2023 by taking 6 months average consumption of present meter (i.e. IMR "0" KwH on 12/2023 and FMR "258" KwH on 05/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
