GIST OF THE COMPLAINT:

The complainant consumer Sri Raju Majhi, At- Dangariguda, Po- Udesurung, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt.11.01.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ DOM supply with CD of 1 KW having consumer No 9043-4312-0157 under SDO Elect. Dharamgarh.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To Withdraw the meter rent.

 - The consumer is complaining about bill revision.
 - The Consumer complained about meter rent as it is a soubhagya meter.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer is complaining about bill revision.
- As per billing database the meter rent has levied from 02/2022 to 02/2024, as the meter has installed in soubhagya scheme.

ORDER 19.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the meter rent from 02/2022 to 02/2024 and not to levied the meter rent for onwards.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
