GIST OF THE COMPLAINT:

The complainant consumer Sri Upendra Bag, AT/Po- Chapria, Ps- Kegaon Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 19.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer no- 9043-4313-0022 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the abnormal bill was served in the month of 06/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the abnormal bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Dharamgarh as follows:

• Billing was average from 09/2008 to 12/2013, and meter was installed on 02/2014 and 07/2024, and billing is actual till now.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that, the billing was average from 09/2008 to 12/2013, and meter was installed on 02/2024 and 07/2024, and billing is actual till now.
- As per billing database the meter no. LW622368 was installed on 05.05.2022 and the final meter reading was 6619 KwH on 21.07.2024 as mentioned by MMG in meter change report. And the bill revision for the period of 06/2022 to 10/2023 & 06/2024 to 11/2024 was take in place, effect on 11.03.2024 & 16.12.2024 respectfully.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 05/2022 to 06/2024 with IMR "0" KwH on 05/2022 and FMR "6619" KwH on 06/2024.
- > To withdraw the earlier bill revision was effect on dtd. 11.03.2024 and 16.12.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
