#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Nanda Nag, AT/Po- Sanchergaon, Ps- Golamunda, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Dharamgarh on dt. 08.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9043-4314-0236 under SDO Elect. Dharamgarh.
- 2) The consumer is complaining about bill revision during the period June 2023 in which 2879 units billed at a time and meter was changed. The billing is actual till now.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

 The consumer is complaining about bill revision during the period June 2023 in which 2879 units billed at a time and meter was changed. The billing is actual till now.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer is complaining about bill revision during the period June 2023 in which 2879 units billed at a time and meter was changed. The billing is actual till now.

### ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 01/2021 to 07/2023 taking IMR "0" KWH and FMR "5363" KWH on 07/2023.

The case is disposed of accordingly.
