**GIST OF THE COMPLAINT:**

The complainant consumer Sri Chandramani Majhi, Repr. by Sri Jubraj Majhi, At- Karla, Po- Badchergaon, Ps- Kegaon, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 09.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.50 KW having consumer no- **9043-4320-0271** under SDO Elect. Dharamgarh.
- 2) As complained by the complainant abnormal excess bill was served in the month of 02/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 23/01/2025
- 2) Bill details from: 11/2011 to 12/2024
- 3) Date of supply: 21/11/2011
- 4) Category: LT/Domestic



- 5) Connected Load 1.50 KW
- 6) Meter No – LW214480
- 7) Installed on: 21/11/2011 with IMR "0"
- 8) CMR: 9399 Kwh as on 23/01/2025
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Dharamgarh as follows:
  - Suppress reading 4700 units billed on 02/2023 and billing is actual till now.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that suppress reading 4700 units billed on 02/2023 and billing is actual till now.
- As per billing database the complainant was availed OTSS on dtd. 27.02.2023, but the suppressed meter reading bill was raised in 02/2023 for 4761 units.

#### **ORDER**

**28.01.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 01/2021 to 12/2024 with IMR "1120" Kwh on 01/2021 and FMR "9380" Kwh on 12/2024. As complainant was availed OTSS on dtd. 27.02.2023.

The case is disposed of accordingly.
