#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Adal Pujhari, At/Po- Badchergaon, Ps- Kegaon, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Golamunda on dt. 22.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.4 KW having consumer no-9043-4320-0881 under SDO Elect. Dharamgarh.
- 2) As complained by the complainant that the bill was raised in high consumption from 03/2018 to 04/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

## SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Dharamgarh) in its counter reply and course of hearing submitted as follows:

2) Bill details from: 04/2018 to 05/2024

3) Date of supply: 18/03/2018



4) Category: LT/Domestic5) Connected Load 0.4 KW

6) Meter No - 1866911

7) Installed on: 18/03/2018 with IMR: "0"8) CMR: 4336 KwH as on 01/11/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Dharamgarh as follows:

• The consumer is complaining about bill revision of previous bill of wrong billing periods from 04/2018 to till date as 3006 units billed on 04/2023.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the consumer is complaining about bill revision of previous bill of wrong billing periods from 04/2018 to till date as 3006 units billed on 04/2023.
- As per billing database some bill was raised with high consumption meter reading, which seems supress meter reading. And the bill was generated in "X" code on 04/2024 & 05/2024, then no bill has generated. But as per report of SDO, Dharmagarh the meter status is OK, and the FMR is "4336" KwH on 01.11.2024.

# ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 03/2018 to 11/2024 with IMR "0" KwH on 03/2018 and FMR "4336" KwH on 01.11.2024.
- > To serve the bill to the complainant on actual basis.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
