OBSERVATIONS OF THE FORUM

From the database and statement as submitted by SDO(Elect.) Dharamgarh, the Forum observed that abnormal billing raised due to defective meter from 06/2023 onwards to consumer. A new meter is installed on date 07/12/23 having serial number TWSP51087091 as per data base.

ORDER 29.12.2023

Based on the above observations, the Forum passes the following order as per regulations 155 of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

1. To revise the abnormal and defective bill from 06/2023 to 11/2023 basing upon six-month average consumption of the new meter installed on 07/12/2023.

Case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
