GIST OF THE COMPLAINT:

The complainant consumer Sri Srikant Kharsel, At- Santemri, Po- Arebeda,Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 11.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9044-4103-1164** under SDO Elect. Charbahal.
- 2) As complained by the complainant that abnormal bill was raised from 01/2021 to 10/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 01/2021 to 02/2025
- 3) Date of supply: 28/12/2020
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWNX509093
- 7) Installed on: 17/11/2023 with IMR "0"



- 8) CMR: 708 KWH on 26/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - Consumer got average unit of bill from bill month 05/2021 to 10/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer got average unit of bill from bill month 05/2021 to 10/2023.
- As per billing database abnormal bill was served from 01/2021 to 10/2023.

ORDER

29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 01/2021 to 10/2023 by taking IMR "0" Kwh on 11/2023 and FMR "245" Kwh on 04/2024.


The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
