The complainant consumer Smt. Padmini Naik, Repr. by Sri Dharmendra Naik, AT/Po- Ranmal, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 13.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.04 KW having consumer no- 9044-4104-0666 under SDO Elect. Charbahal.
- 2) The average bill may revise from 08/2022 to 08/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer had charged 2951 bill unit at a time as a suppress bill on bill month 07/2022.
- Defective period bill revise requires from 09/2022 to 08/2023.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 05/2018 to 07/2022 taking IMR "0" KWH on 05/2018 and FMR "4051" KWH on 07/2022.
- To revise the bill from 08/2022 to 08/2023 taking six-month average consumption of new meter install on 16/10/2023 taking IMR "0" KWH on 10/2023 and FMR "78" KWH on 03/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
