GIST OF THE COMPLAINT:

The complainant consumer Sri Kanhu Charan Thakur, Repr. by Smt. Manisha Behera, AT/Po- Deundi, Ps- Junagarh, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 13.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- **9044-4109-0236** under SDO Elect. Charbahal.
- 2) Consumer complaint for excess bill in a month of 04/2016 and 10/2016.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 04/09/2024
- 2) Bill details from March 2001 to August 2024



- 3) Date of supply 01/01/1990
- 4) Category: LT/Domestic
- 5) Connected Load 1.50 KW
- 6) Meter No – TWSP51162261
- 7) Installed on 27/05/2024 with IMR: "0"
- 8) CMR: 155 Kwh as on 04/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - Consumer had charged 3752 bill unit at a time as a suppress bill on bill month 04/2016.
 - Defective period bill revise requires from 02/2018 to 02/2019.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer had charged 3752 bill unit at a time as a suppress bill on bill month 04/2016.
- Defective period bill revise requires from 02/2018 to 02/2019.

ORDER

30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:


- To recast the bill from 08/2013 to 12/2017 taking IMR "0" KWH on 08/2013 and FMR "13375" KWH on 12/2017.
- To revise the bill from 01/2018 to 02/2019 taking IMR "0" KWH on 03/2019 and FMR "100" KWH on 08/2019.

The case is disposed of accordingly.
