
The complainant has appeared and submitted during course of hearing at camp court at GRF office Bhawanipatna on dt. 25.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 91.50 KW having consumer no- 9044-4111-0253 under SDO Elect. Charbahal.
- 2) As complained by the complainant that the necked wire connection from the transformer to the pole which wrongs directly above residential house.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:
