GIST OF THE COMPLAINT:

The complainant consumer Sri Keshab Nag, At- Nuaguda, Po- Dahagaon, Ps- Koksara, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 11.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- 9044-4116-0006 under SDO Elect. Charbahal.
- 2) As complained by the complainant that abnormal bill was served from 11/2015 to 06/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

11) As written version submitted by SDO Elect. Charbahal as follows:

• Consumer got 4791 unit of bill at a time in bill month 10/2022. The DPS has also levied from 06/2018 to 03/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer got 4791 unit of bill at a time in bill month 10/2022. The DPS has also levied from 06/2018 to 03/2023.
- As per billing database some bill was served in high unit consumption meter reading during the period from 11/2015 to 06/2023, which seems supress meter reading. And penalty was levied twice in the month of 06/2019 and 12/2019 an amount of Rs. 4937/- & Rs. 4935/- respectively. And DPS was levied from 06/2018 to 03/2023.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 11/2015 to 06/2023 with IMR "0" KwH on 11/2015 and FMR "9722" KwH on 06/2023.
- To withdraw the penalty amount wrongly debited twice during the FY 2019-20 in co-ordination with enforcement team.
- To withdraw the DPS amount from 10/2021 to 03/2023 as it is a domestic category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
