GIST OF THE COMPLAINT:

The complainant consumer Sri Udenath Hans, At- Nuaguda, Po- Dahagaon, Ps- Koksara, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 11.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- 9044-4116-0702 under SDO Elect. Charbahal.
- 2) As complained by the complainant that at the time of meter change the FMR was "1204" KwH on dtd. 23.02.2024, whereas the bill was generated with wrong meter reading during the month of 08/2022 (i.e. "2650" KwH)
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 26/03/2025
- 2) Bill details from: 02/2022 to 02/2025
- 3) Date of supply:13/12/2019
- 4) Category: LT/Domestic
- 5) Connected Load 0.04 KW



7) Installed on: 23/02/2024 with IMR "0"

8) CMR: 648 KWH on 26/03/2025

9) The meter status: OK

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Charbahal as follows:

• Consumer got 1650 unit of bill at a time in bill month 08/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer got 1650 unit of bill at a time in bill month 08/2022.
- As per billing database the bill was generated "2650" KwH on 08/2022, whereas the meter change report appears that the old meter final reading on dtd.28.03.2024 was "1204" KwH. And bill revision towards supress bill recast from the period 12/2019 to 08/2022, effect on dtd. 23.11.2024.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the earlier bill revision for the period from 12/2019 to 08/2022, effect on dated 23/11/2024.
- To revise the bill for the month of 08/2022 by taking six-month average consumption of present meter (i.e. IMR "0" KwH on 02/2024 and FMR "292" KwH on 07/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
