- 2) As complained by the complainant that excess average bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

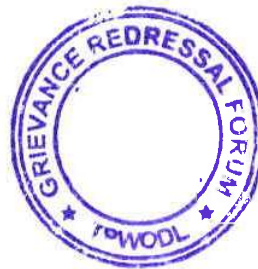
The complainant has prayed for:

FINDINGS / OBSERVATIONS OF THE FORUM

- The complainant reiterated for excess billing.
- The OP stated that Consumer got average bill from 09/2013 to 09/2015.
- As per billing database the average/Provisional bills were served

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 10/2013 to 09/2015 taking IMR "0" Kwh on 10/2015 and FMR "120" Kwh on 03/2016.

The case is disposed of accordingly.
