GIST OF THE COMPLAINT:

The complainant consumer Sri Gunanidhi Naik, Repr. by Sri Manish Kumar Naik, At- Dulkibandh, Po- Bijmara, Ps- Kalampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Badkutru on dt. 14.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 3 KW having consumer no- **9044-4307-0161** under SDO Elect. Charbahal
- 2) As complained by the complainant that excess bill was served for the month of 03/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 17/02/2025
- 2) Bill details from: 03/2005 to 01/2025
- 3) Date of supply: 25/03/2005
- 4) Category: LT/Domestic



- 5) Connected Load 3 KW
- 6) Meter No – TW02071935
- 7) Installed on: 23/08/2022 with IMR “0”
- 8) CMR: 4649 KWH on 17/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - As per PVR consumer meter no- TW0207936 is installed on premises on date 23/08/2022 instead of date 23/05/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that s per PVR consumer meter no- TW0207936 is installed on premises on date 23/08/2022 instead of date 23/05/2023.
- As per billing database nominal units were billed for the month of 09/2022 to 03/2023 but as per PVR of JE intimated that the meter was installed on 23.08.2022 instead of 23.05.2023 as recorded in database. Rs. 13354.83 was debited for the defective period from 08/2022 to 04/2023 on dtd. 27.12.2024.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 08/2022 to 01/2025 by taking IMR “0” Kwh on 08/2022 and FMR “4581” Kwh as on 01/2025.
- To withdraw the upward assessment raised on 27.12.2024 for meter mismatch period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by **March-25** the opposite party after compliance otherwise it will be treated as non-compliance.
