GIST OF THE COMPLAINT:

The complainant consumer Sri Rajib Bachha, AT/Po- Bijmara, Ps- Kalampur, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 13.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- 9044-4307-0183 under SDO Elect. Charbahal.
- 2) As complained by the complainant that the provisional/average bill was served from 09/2015 to 05/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 02/09/2024
- 2) Bill details from November 2013 to August 2024
- 3) Date of supply 30/12/2012



- 5) Connected Load 1.50 KW
- 6) Meter No TPWODL1031320
- 7) Installed on 14/04/2023 with IMR: "0"
- 8) CMR: 4029 KwH as on 02/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill

As written version submitted by SDO Elect. Charbahal as follows:

 Consumer had charged 2077 bill unit at a time as a suppress bill on bill month 05/2022 and 1377 unit on 04/2023 bill month.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Consumer had charged 2077 bill unit at a time as a suppress bill on bill month 05/2022 and 1377 unit on 04/2023 bill month.
- As per billing database, it is seen that provisional bills were served to the complainant due to meter no mismatch from the billing month of Aug/Sep-2022 to Feb/Mar-2023 and in the month of April-2023 a bill was served with 1377 units showing meter change having SI no. TPWODL1031320. So it is presumed that the meter having SL no. TPWODL1031320 was replaced in the month of Aug-2022 instead of April-2023. So, bills during this period to be recasted accordingly.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 08-09/2015 to 05/2022 with IMR "0" KwH on 08/2015 and FMR "9233" KwH on 05/2022.
- To recast the bill from 08-09/2022 to April-2023 with IMR "0" KwH on 08/2022 and FMR "1353" KwH on 04/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
