GIST OF THE COMPLAINT:

The complainant consumer Sri Ghasiram Gahir, At- Dulkibandh, Po- Bijmara, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Badkutru on dt. 14.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- **9044-4307-0306** under SDO Elect. Charbahal
- 2) As complained by the complainant that abnormal excess bill was served in the month of 01/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 14/02//2025
- 2) Bill details from: 11/2015 to 01/2025
- 3) Date of supply: 14/10/2015
- 4) Category: LT/Domestic
- 5) Connected Load 0.04 KW



- 6) Meter No – LW312132
- 7) Installed on: 06/04/2022 with IMR “330”
- 8) CMR: 3032 KWH on 14/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - Consumer got 654 unit of low suppress bill at a time in bill month 01/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer got 654 unit of low suppress bill at a time in bill month 01/2022.
- As per billing Database the monthly bill was served with low consumption as actual meter reading but 654 units was billed in the month of 01/2022 which seems to be suppressed meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 10/2015 to 01/2022 taking IMR “0” Kwh on 10/2015 and FMR “2560” Kwh on 01/2022

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
