The complainant has appeared and submitted during course of hearing at camp court at Badkutru on dt. 14.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9044-4308-0664 under SDO Elect. Charbahal
- 2) As complained by the complainant that excess provisional bills were served.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for excess billing.

The OP stated that Consumer got average bill from 05/2021 to 04/2024.

As per billing database excess provisional bill were served. The new meter was installed on 06.06.2024.

# **ORDER**

#### 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 03/2021 to 02/2023 taking six-month average consumption of new meter installed on 06.06.2024 with IMR "130" KwH on 06/2024 and FMR "615" KwH on 11/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
