GIST OF THE COMPLAINT:

The complainant consumer Sri Radhadhan Banua, Repr. By Sri Radhamohan Banua, At-Podaguda, Po-Khaliabhata, Ps-Jaipatna, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 18.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9044-4308-1110 under SDO Elect. Charbahal.
- 2) As complained by the complainant that Rs. 10,470/- was charged as penalty but the actual bills was served from date of power supply to till date in the same meter on actual basis.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 10/2024 to 06/2025
- 3) Date of supply: 28.04.2022
- 4) Category: LT/Domestic
- 5) Connected Load: 1 KW
- 6) Meter No 2345074
- 7) Installed on: 28.04.2022 with IMR "0"
- 8) CMR: 4492 KWH on 28/07/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - The consumer paid penalty amount 10470 on 04.03.2024 & the new bill has generate as per kha mission after bill generated the consumer has charged full consuption

reading 3476 units, which is double charged one is penalty & other consumption amount. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the The consumer paid penalty amount 10470 on 04.03.2024 & the new bill has generate as per khi mission after bill generated the consumer has charged full consuption reading 3476 units, which is double charged one is penalty & other consumption amount
- The bill was generated in 10/2024 for 3476 units for 31 months (i.e., 04/2022 to 10/2024)
- Meter No. 235074 had been installed on dt. 28.04.2022 and the CMR is "4492" KwH as on dt. 28.07.2025.

ORDER 31.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

The penalty amount of Rs. 10,470/- towards unuthorize connection to be withdrawn in co-ordination with enforcement.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by August-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
