**GIST OF THE COMPLAINT:**

The complainant consumer Sri Chetu Naik, Repr. by Sri Jaga Naik, At/Po-Badpujhariguda, Ps-Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Badkutru on dt. 26.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- **9044-4312-0756** under SDO Elect. Charbahal.
- 2) As complained by the complainant that abnormal excess bill was served for the month of 08/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/11/2024
- 2) Bill details from: 10/2018 to 10/2024
- 3) Date of supply: 15/09/2018
- 4) Category: LT/Domestic



- 5) Connected Load 0.50 KW
- 6) Meter No – 3009703
- 7) Installed on: 15.09.2018 IMR "0" Kwh
- 8) CMR: 4982 Kwh as on 28/11/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
  - Consumer had charged 4788 unit at a time on bill month 08/2024.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer had charged 4788 unit at a time on bill month 08/2024.
- As per database the meter reading for the month of 08/2020 to 07/2024 was very low less than 100 units per month but all of a sudden 4788 units was served for the month of 08/2024. The PVR report submitted by the J.E Badkutru that the FMR is 4982 Kwh as on 28.11.2024. it attributes to table meter reading submitted by the meter reader.

#### **ORDER**

**29.11.2024**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast from 08/2020 to 09/2024 by taking IMR "0" Kwh on 08/2020 and FMR "4965" Kwh as on 09/2024.
- To withdraw the bill revision done on 25.03.2023

The case is disposed of accordingly.
