GIST OF THE COMPLAINT:

The complainant consumer Sri Trilochan Naik, repr. by Sri Simanchal Naik, At/Po- Pujhariguda, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Badkutru on dt. 20.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer no-**9044-4313-0143** under SDO Elect. Charbahal.
- 2) As complained by the complainant that the average bill was served from 12/2002 to 12/2002.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 5) Connected Load 1.5 KW

- 8) CMR: 2987 Kwh as on 09/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:

- Defective period bill revision required from 12/2002 to 12/2003.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that defective period bill revision required from 12/2002 to 12/2003.
- As per billing database the average bill was served as without meter from 12/2002 to 12/2003.

ORDER

28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To revise the bill from 12/2002 to 12/2003 by taking six-months average consumption of meter install on 01/2004 (i.e. IMR "0" Kwh on 01/2004 and FMR "245" Kwh on 06/2004).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
