**GIST OF THE COMPLAINT:**

The complainant consumer Sri Rupsingh Patra, Repr. by Sri Mahendra Patra, At- Podakhoh, Po/Ps- Ailabhata, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Badkutru on dt. 14.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- **9044-4316-0432** under SDO Elect. Charbahal
- 2) As complained by the complainant that abnormal excess bill was served in the month of 04/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 16/02/2025
- 2) Bill details from: 06/2012 to 01/2025
- 3) Date of supply: 12/02/2012
- 4) Category: LT/Domestic



- 5) Connected Load 0.04 KW
- 6) Meter No – TWNX310848
- 7) Installed on: 08/01/2024 with IMR: “0”
- 8) CMR: 514 KWH on 16/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
  - Consumer got 2520 unit of bill at a time in bill month 04/2021.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer got 2520 unit of bill at a time in bill month 04/2021
- As per billing database a meter number LW512453 was installed on 10.12.2020 but the bill for the month of 04/2021 was billed for 2520. which seems to be absurd units billed.

### **ORDER**

**28.02.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill for 04/2021 by taking IMR “0” Kwh on 01/2024 and FMR “169” Kwh on 06/2024.

The case is disposed of accordingly.
