#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Mansingh Majhi, Repr. By Sri Basanta Kumar Majhi, At/Po-Ainly, Po-Koksara, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at GRF BPT office dt. 18.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- 9044-4320-0177 SDO Elect. Charbahal.
- 2) As complained by the complainant that the bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

  - As per PVR and documents, A meter has been installed on dated 01.12.2024. so do the needful for revision. However, the respondent requested the forum to take appropriate decision as necessary.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR and documents, A meter has been installed on dated 01.12.2024, so do the needful for revision.
- From 03/2001 to 01/2012 provisional / average bills have been served.
