## **GIST OF THE COMPLAINT:**

The complainant consumer Smt. Sarita Naik repr. by Sri Binit Kumar Naik, At/Po-Jaipatna, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Jaipatna on dt. 24.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer no-9044-4401-0414 under SDO Elect. Charbahal.
- 2) As complained by the complainant the bill for the month of 07/2015, 05/2016 and 07/2019 was served for 3530 units, 1422 units and 1003 units for a month respectively, which may be considered.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

# ORDER 28.10.2024

The OP is directed as follows:

To recast the bill from 03/2012 to 06/2021 with IMR 0KWH on 03/2012 and FMR 25609 KWH on 06/2021.

The case is disposed of accordingly.
