#### GIST OF THE COMPLAINT:

The complainant consumer Sri Ghanashyam Panda, At- Kishorpada, Po/Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 17.04.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- 9044-4401-0525 under SDO Elect. Charbahal.
- 2) As complained by the complainant that the bill was generated in disconnection period from 01/2020 to 12/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR, consumer not available in his premises since 01/2020 to 12/2024.
- As per billing database the provisional/average bill was served from 04/2019 to 12/2024.

### ORDER 30.04.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To withdraw the bill from 01/2020 to 12/2024 (excluding fixed charges).
- > The complainant is directed to pay the outstanding arrear bill till 12/2019.

The case is disposed of accordingly.
