#### GIST OF THE COMPLAINT:

The complainant consumer Sri Ramkrushna Padhi, At/Po- Jaipatna, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Jaipatna on dt. 24.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2.5 KW having consumer no-9044-4401-0581 under SDO Elect. Charbahal.
- 2) As complain by the complainant the excess average / provisional bill has served during meter defective period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that average bill has generated from 12/2007 to 01/2020 bill need to revised of that period.

## o ORDER ଅ<u>ଷ୍ଟ୍ରୀ 0.</u>2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 02/2018 to 01/2020 by taking six-moth average consumption of meter install with IMR 0 KWH on 02/2020 and FMR 783 KWH on 07/2020.
- To recast the bill from 02/2020 to 08/2024 taking IMR 0 KWH on 02/2020 and FMR 8666 KWH on 08/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
