**GIST OF THE COMPLAINT:**

The complainant consumer Sri Somnath Nag repr. by Sri Tarun Nag, At/Po- Jaipatna, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Jaipatna on dt. 24.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.5 KW having consumer no-**9044-4402-0404** under SDO Elect. Charbahal.
- 2) As complained by the complainant abnormal bill for the month of 04/2016 was served for 3008 units for a month, which may be considered.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

- The complainant reiterated for excess billing.
- The OP stated that Consumer had charge 3008 units at a time on 04/2016 bill month.

### **ORDER** **28.10.2024**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To recast the bill from 09/2013 to 09/2016 with IMR 0 KWH on 09/2013 and FMR 4473 KWH on 09/2016.


The case is disposed of accordingly.

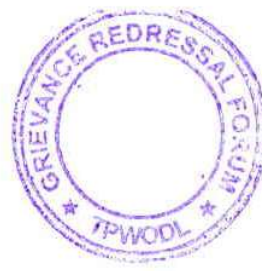
