**GIST OF THE COMPLAINT:**

The complainant consumer Sri Shiba Prasad Baitharu, Repr. by Sri Deva Prasad Baitharu, At/Po-Mukhiguda, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Jaipatna on dt. 14.05.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9044-4404-0605** under SDO Elect. Charbahal.
- 2) As complained by the complainant that abnormal bill was raised in 03/2025.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/04/2025
- 2) Bill details from: 01/2020 to 04/2025
- 3) Date of supply: 21.01.2020
- 4) Category: LT/Domestic

- 5) Connected Load 1 KW  
6) Meter No – TWST1701792  
7) Installed on: 30.03.2024 with IMR "0"  
8) CMR: 6081 KWH on 19/05/2025  
9) The meter status: OK  
10) Facts of the complainant: Revision of bill  
11) As written version submitted by SDO Elect. Charbahal as follows:
- As per PVR, the installed meter no. TWST1701792 is found ok & CMR is 6081. The consumer has the connected load is 4 KW while the sanction load is 1 KW.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR, the installed meter no. TWST1701792 is found ok & CMR is 6081. The consumer has the connected load is 4 KW while the sanction load is 1 KW.
- As per billing database the meter change assessment was take in place on dtd. 28.03.2025. whereas the complainant was intimate to the JE, Jaipatna that the meter was burnt on dtd. 28.06.2023, but concern JE was not taken any action towards meter change, resulting that the complainant was getting the average bill from 06/2023 to 03/2024.
- As the connected load is 4 KW against the sanctioned contact demand is 1 KW, and the bill was assessed on new meter installed, as per regulation 155 of conditions of supply-2019 of OERC so further bill revision not required.

### ORDER

31.05.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- As the bill revision was taken in place, so no need to revise the bill.

Case is disposed of accordingly. The case is hereby **Dropped**.
