The complainant consumer Sri Harish Chandra Naik, Repr. by Sri Kousik Naik, At- Sargiguda, Po-Karmeli, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent. The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 19.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- 9044-4405-0234 under SDO Elect. Charbahal.
- 2) As complained by the complainant that excess abnormal bill was served in the month of 03/2016.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

- The OP stated that Consumer got 1779 units of bill at a time in bill month 03/2016.
- As per billing database some bill was served in high consumption meter reading, which seems supress meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 05/2012 to 05/2017 by taking IMR "0" KwH on 05/2017 and FMR "2765" KwH on 05/2017.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
