#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Alekha Bhakta AT- Karanjiguda, Po- Ranibahal, Ps- Jaipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 05.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer no- 9044-4409-0200 under SDO Elect. Charbahal.
- 2) As complained by the complainant that wrong billing for the period from 11/2018 to 06/2019.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the wrong billing.

## SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from February 2014 to July 2024
- 3) Date of supply 29/01/2013



- 4) Category: LT/Domestic
- 5) Connected Load 1.5 KW
- 6) Meter No LW280506
- 7) Installed on 18/05/2019 with IMR: "1"
- 8) CMR: 22575 KWH as on 29/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
  - Consumer meter was found OK and CMR is 22575 KWH, consumer had charge 5617 bill units at a time in round complete status on bill month 02/2019.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that Consumer meter was found OK and CMR is 22575 KWH, consumer had charge 5617 bill units at a time in round complete status on bill month 02/2019.
- As per billing database 14082 units was billed in the month of 12/2023, which seems supress meter reading.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To revise the bill from 11/2018 to 04/2019 by taking six-month average consumption of present meter (i.e. IMR "0" KwH on 05/2019 and FMR "1955" KwH on 10/2019.
- > To revise the bill by way of recasting from 05/2019 to 12/2023 with IMR "0" KwH on 05/2019 and FMR "20272" KwH on 12/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
