GIST OF THE COMPLAINT:

The complainant consumer Sri Haldhar Naik, AT- Khamarpadar, Po- Mahulpatna, Ps- Th. Rampur, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Jaipatna on dt. 11.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 0.04 KW having consumer no- 9044-4411-0270 under SDO Elect. Charbahal.
- 2) As complained by the complainant that abnormal excess bill in the month of 06/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal.) in its counter reply and course of hearing submitted as follows:

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Charbahal.as follows:

• Consumer had charged at a time 5842-unit bill in the month of 06/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer had charged at a time 5842-unit bill in the month of 06/2023.
- As per database the meter was changed on 25/11/2021 but the bill was generated on average basis from 11/2021 to 05/2023. All of a sudden, the actual bill was served for 5842 units for a month which seems to be abnormally high for a month.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 11/2021 to 11/2024 by taking IMR "1" KWH on 11/2021 and FMR "8318" KWH on 11/2024.
- To withdraw the bill revision that on 12/03/2024 and 14/03/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
