GIST OF THE COMPLAINT:

The complainant consumer Sri Dwitikrishna Naik, AT/Po- Koksara, Ps- Koksara, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 13.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- 9044-5208-0202 under SDO Elect. Charbahal.
- 2) As complained by the complainant that the bill was raised during line disconnection period and to permanently close the account.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To withdraw the bill raised during the disconnection period.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 05/09/2024
- 2) Bill details from November 2002 to July 2024
- 3) Date of supply 19/09/2001



- 5) Connected Load 1.50 KW
- 6) Meter No N/A
- 7) Installed on N/A
- 8) CMR: N/A
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - As per PVR there is no power supply available at site since long years ago.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that as per PVR there is no power supply available at site since long years ago.
- As per PVR submitted by JE Koksara the house was demolished and now supply not available since long year ago and Sri Tulsi Naik lineman C has sign in PVR report in token up line disconnected since long.
- Neither complainant nor respondent could able to provide any documents regarding date of disconnection of power supply. But both agreed that the power supply to the premises is under disconnection as on date and the house is demolished.
- As per database provisional / average bill were billings served to the consumer from 05/2019 to till date and no payment was made by the consumer during this period.
- So, it is presumed that supply may have been disconnected at any time after 05/2019 but not known to anyone either complainant or respondent.
- However, under regulation 157 of OERC distribution (Condition of supply) code 2019, 2 years provisional/ average bill prior to the month of consumer made PDC that is 07/204 can be withdrawn.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

 To withdraw the bill from 07/2022 to 06/2024 as the consumer was declare as PDC consumer on 07/2024 and intimate the final bill to consumer to clear the balance amount.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
