GIST OF THE COMPLAINT:

The complainant consumer Sri Jagannath Naik, AT- Panigaon, Po- Rengalpali, Ps-Koksara, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 05.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.5 KW having consumer no- **9044-5211-0054** under SDO Elect. Charbahal.
- 2) As complained by the complainant the excess bill in defective period to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/08/2024
- 2) Bill details from November 2007 to April 2024
- 3) Date of supply 14/07/2006
- 4) Category: LT/Domestic



- 5) Connected Load 1.5 KW
- 6) Meter No – LW590134
- 7) Installed on 18/03/2020 with IMR: "1"
- 8) CMR: 1233 KWH as on 28/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - Defective period bill revision required.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the defective period bill revision required.
- As per billing database provisional/average bill was raised from 06/2016 to 06/2020.
- As per billing database bill revision was done for the period 03/2020 to 12/2022 against delay meter updating with a 'cr' sundry amounting to 1167.02 on date 22.02.2023.

ORDER

31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To revise the bill from 03/2018 to 02/2020 by taking six-month average consumption of present meter no. LW590134 (i.e. IMR "1" Kwh on 03/2020 and FMR "80" Kwh on 08/2020).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
