GIST OF THE COMPLAINT:

The complainant consumer Sri Asharam Naik, Repr. by Sri Satya Naik, At- Kendudungri, Po-Baradonga, Ps- Ampani, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 19.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.5 KW having consumer no- **9044-5212-0306** under SDO Elect. Charbahal.
- 2) As complained by the complainant that abnormal excess bill was served during the month of 05/2019 to 12/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

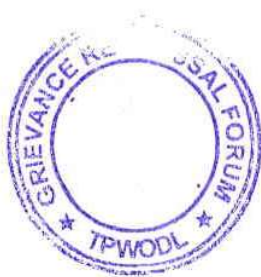
The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 01/03/2025
- 2) Bill details from: 03/2001 to 01/2025
- 3) Date of supply: 01/01/1990



- 4) Category: LT/Domestic
- 5) Connected Load 1.5 KW
- 6) Meter No – 300043359
- 7) Installed on: 10/01/2023 with IMR "0"
- 8) CMR: 5736 KWH on 01/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - Consumer got 3761 units of bill at a time in bill month 03/2009.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Consumer got 3761 units of bill at a time in bill month 03/2009.
- As per billing database it seems that the meter installed during 05/2019 to 12/2020 was recording abnormal meter reading.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To revise the bill from 03/2004 to 03/2009 with IMR "0" Kwh on 03/2004 and FMR "3761" Kwh on 03/2009.
- To revise the bill from 05/2019 to 12/2020 by taking six months average consumption of meter installed on 01/2021 (i.e IMR "0" Kwh on 01/2021 and FMR "350" Kwh on 06/2021).


The case is disposed of accordingly.

Compliance report must be submitted to the Forum by March-25 the opposite party after compliance otherwise it will be treated as non-compliance.
