#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Gopal Chandra Sahu, AT/Po- Ampani, Ps- Ampani, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Koksara on dt. 12.06.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ General Purpose supply with CD of 1 KW having consumer no- 9044-5214-1136 under SDO Elect. Charbahal.
- 2) As complained by the complainant the provisional bill was generated during the disconnection period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the provisional bill.

## SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

# FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that as per PVR consumer supply is not available since supply date -06/01/2022.
- As per FIR copy of Koksara P.S that the meter of the name of Ba Akhandalamani campus on 07/03/2022 broke a tree and fell down under said electrical meter and damage.

# ORDER 31.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 01/2022 to 10/2023 as the power supply was not available.
- > The complainant is directed, to deposit the fixed charges as appropriate prior to restore of the power supply if wants to restore power supply with same consumer number in the same premises.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
