GIST OF THE COMPLAINT:

The complainant consumer Sri Murlidhar Panda, AT/Po- Ampani, Ps- Ampani, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Charbahal on dt. 13.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 0.50 KW having consumer no- 9044-5215-0081 under SDO Elect. Charbahal.
- The consumer has intimated to JE Charbahal to disconnect the power supply and the JE also signed in token up receive the application on 21/01/2003.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from March 2001 to July 2024
- 3) Date of supply 01/01/1990



- 4) Category: LT/General Purpose
- 5) Connected Load 0.50 KW
- 6) Meter No N/A
- 7) Installed on N/A

- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
 - As per PVR there is no power supply available at site since long years ago.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per PVR there is no power supply available at site since long years ago.
- The JE Charbahal has certified that the power supply was disconnected on dt.15/03/2003 as per party request.
- As seen from database consumer was paying electric bill regularly upto March 2019. Then after there is no payment made by consumer and bills were also generated on L.F basis. So it is presumed that the power supply got disconnected since 04/2019.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill amount excluding the fixed charges from 04/2019 to 08/2024.
- If consumer want to avail the power supply after depositing the appropriate amount with reconnection charges as per OERC regulations.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
