**GIST OF THE COMPLAINT:**

The complainant consumer Sri Thabira Mangaraj, Repr. By Sri Tushar Mangaraj, At/Po-Gotomunda (Thutibar), Ps-Ampani, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Koksara on dt. 18.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.04 KW having consumer no-**9044-5220-0435** under SDO Elect. Charbahal.
- 2) As complained by the complainant that the bill was raised in high consumption in the month of 12/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Charbahal) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 06/11/2024
- 2) Bill details from: 08/2016 to 10/2024
- 3) Date of supply: 20/12/2015
- 4) Category: LT/Domestic



- 5) Connected Load 0.04 KW
- 6) Meter No – 300011848
- 7) Installed on: 27/04/2022 with IMR: "0"
- 8) CMR: 4006 Kwh as on 06/11/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Charbahal as follows:
  - Consumer had charged 2657 unit at a time on bill month 12/2021.

#### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that consumer had charged 2657 unit at a time on bill month 12/2021.
- As per billing database the bill was raised in high consumption in the month of 12/2021 with 2657 units, which seems suppress meter reading. And the bill revision towards delay meter updating was take in place from 04/2022 to 06/2022, effect on dtd. 09.09.2022.

#### **ORDER**

**14.11.2024**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 12/2019 to 12/2021 with IMR "0" Kwh on 12/2019 and FMR "3182" on 12/2021.
- To recast the bill from 03/2022 to 12/2022 with IMR "0" Kwh on 03/2022 and FMR "1629" on 12/2022.
- To withdraw the bill revision effect on dtd. 09.09.2022, and DPS from 04/2022 to 03/2023.

The case is disposed of accordingly.
