GIST OF THE COMPLAINT:

The complainant consumer Sri Suresh Ada, At-Nehrupada Ward No-13, Po/Ps-Khariar Road, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar Road on dt. 20.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/IRR supply with CD of 2 KW having consumer no- 9060-0101-5758 under EE, NED, Nuapada.
- 2) As complained by the complainant that some abnormal excess bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, NED, Nuapada) in its counter reply and course of hearing submitted as follows:

- 1) Test Report: 25.09.2025
- 2) Bill details from: 07/2021 to 08/2025
- 3) Date of supply: 02.07.2021
- 4) Category: LT/IRR
- 5) Connected Load: 2 KW
- 6) Meter No – TWSP51034159
- 7) Installed on: 30.09.2023 with IMR "0"
- 8) CMR: 11021 KwH on Dt. 25.09.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, NED, Nuapada as follows:
 - The consumer was billed on average basis from 09/2021 to 08/2023. As per the FG data, Meter sl no. TWSP51034159 was installed on dated 30.09.2023. then, bill has been revised the defective period by taking six months actual consumption from the date of meter installation i.e, 09/2023 to 03/2024. Consumer has requested to re-



evaluate the defective period assessment. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer was billed on average basis from 09/2021 to 08/2023. As per the FG data, Meter sl no. TWSP51034159 was installed on dated 30.09.2023. then, bill has been revised the defective period by taking six months actual consumption from the date of meter installation i.e, 09/2023 to 03/2024. Consumer has requested to re-evaluate the defective period assessment
- Meter no. TWSP51034159 had been installed on dt-30.09.2023 and the CMR is 11021 KWh on dt-25.09.2025.

ORDER



Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- The bills served from 09/2021 to 08/2023 (2 Years) are to be revised by taking average of 1-year consecutive billing of new meter.
- To withdraw the bill revision was effect on dt-03.09.2024.
- Any adjustments made during the revision period are also be taken into consideration / DPS charged on the wrong bills are also to be withdrawn.
- The complainant must clear all dues upon revision of bills.

The matter is closed herewith. The compliance report to be submitted to the undersigned on or before Dt- 30.11.2025.
