GIST OF THE COMPLAINT:

The complainant consumer Sri Gobinda Hati, At/Po-Nuagaon, Ps- Komna, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 13.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Irrigation supply with CD of 3 KW having consumer No **9060-0101-1680** under EE, NED Nuapada.
- 2) As complained by the complainant the provisional bill was raised from date of power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:
To revise the provisional bill.

FINDINGS / OBSERVATIONS OF THE FORUM

- The complainant reiterated for revision of provisional billing. The OP submitted that the consumer complained for provisional billing up to September 2022.

ORDER **30.05.2024**


Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.
