GIST OF THE COMPLAINT:

The complainant consumer Sri Alekh Meher, At- Gambhariguda, Po- Gondabahali, Ps-Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 26.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 3 KW having consumer no-9060-0101-1883 under EE, NED,
- 2) As complained by the complainant that the provisional bill was raised from date of
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, NED, Nuapada) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from January 2016 to August 2024
- 3) Date of supply: 23/12/2015

- 4) Category: LT/Irrigation Pumping and Agriculture
- 5) Connected Load 3 KW
- 6) Meter No 10056026
- 7) Installed on 24/11/2023 with IMR: "0"
- 8) CMR: 335 KwH as on 04/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, NED, Nuapada as follows:
 - The consumer prayed for re-calculation of his provisional billing. Consumer requested to consider of his current billing as per the actual meter reading by taking average consumption of 12 month and for rectification of his bill amount.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer prayed for re-calculation of his provisional billing. Consumer requested to consider of his current billing as per the actual meter reading by taking average consumption of 12 month and for rectification of his bill amount.
- As per billing database bill revision towards high unit reversed was take in force on dtd. 31/03/2023.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 11/2021 to 10/2023 by taking one-year average consumption of new meter installed on 24/11/2023. Taking into consideration of the amount withdrawn against high unit reversal on dtd. 31.03.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
