FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the consumer has paid the disconnection fees on dtd. 20.06.2017, but the bill still continuing.
- As per billing database a bill revision towards Metered Agriculture High Units Reversed effect on Dt. 31-03-2023.

ORDER 19.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To withdraw the bill from 06/2017 to 02/2024.
- To withdraw the bill revision has effect on dtd. 31.03.2023.
- ➤ The complainant is directed to pay the arrear bill till 05/2017, and if wish to continue the same power supply to the same premises, to pay the requisite reconnection fees along with fix charges from 06/2017 to till date of reconnection.

The case is disposed of accordingly.
