#### GIST OF THE COMPLAINT:

The complainant consumer Sri Sudhir Pujhari, AT/Po- Deodara, Ps- Komna, Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 17.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation supply with CD of 3 KW having consumer no- 9060-0101-5134 under EE, NED, Nuapada
- 2) As complained by the complainant that the abnormal bill was served in the month of 08/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP did not submit any written version.
- As per billing database bill revision towards defective period assessment from 01/2021 to 10/2022 was take in place in basis on 6 months average consumption of present meter reading, effect on dtd. 19.08.2023. Instead of 1-year average consumption of present meter reading, as the complainant is a LT/Irrigation Pumping and Agriculture category.

# ORDER 27.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 01/2021 to 11/2022 by taking 1 year average consumption of present meter (i.e. IMR "0" KwH on 11/2022 and FMR "6734" KwH on 10/2023).
- To withdraw the earlier bill revision effect on dtd. 19.08.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
