GIST OF THE COMPLAINT:

The complainant consumer Sri Bidyadas Satnami, At-Senbhata, Po-Kuliabandha, Dist.- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar Road on dt. 17.10.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/IRR supply with CD of 3 KW having consumer no- 9060-0101-6329 under EE, NED, Nuapada.
- 2) As complained by the complainant that some excess provisional bills were served.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, NED, Nuapada) in its counter reply and course of hearing submitted as follows:

- 1) Test Report: 29.10.2025
- 2) Bill details from: 04/2022 to 09/2025
- 3) Date of supply: 04.04.2022
- 4) Category: LT/Irrigation
- 5) Connected Load: 3 KW
- 6) Meter No – TWSC59039583
- 7) Installed on: 20.01.2025 with IMR "0"
- 8) CMR: 6858 KwH on Dt.29.10.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, NED, Nuapada as follows:
  - The consumer was billed on average basis from May'22 to Dec 24. Then Meter Changed on dated 20.01.2025. As per PVR of MMG- Khariar road, the meter is running vide meter no-TWSC59039582. The Consumer pray for bill revision as per actual



consumption by taking actual units. However, the respondent requested the forum to take appropriate decision as necessary.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement, the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer was billed on average basis from May'22 to Dec 24. Then Meter Changed on dated 20.01.2025. As per PVR of MMG- Khariar road, the meter is running *vide* meter no-TWSC59039582. The Consumer pray for bill revision as per actual consumption by taking actual units.
- From 04/2022 to 12/2024 provisional / average bills have been served.
- There is no scope for bill revision.

### ORDER

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:
