GIST OF THE COMPLAINT:

The complainant consumer Sri Bhupendra Kumar sahu, Repr. By Sri Sidan sahu, At-Saliha, Po-Kodomer, Via-Khariar Road, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during the course of hearing at camp court at Khariar Road on dt. 21.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Irrigation Pumping & Agriculture supply with CD of 3 KW having consumer no- 9060-0101-8011 under EE, NED, Nuapada.
- 2) As complained by the complainant that the pills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, NED, Nuapada) in its counter reply and course of hearing submitted as follows:

 - Revise the fixed charge amount from 07/2024 to 12/2024. However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that revise the fixed charge amount from 07/2024 to 12/2024.
- Abnormal fixed charge was levied from 07/2024 to 12/2024.

ORDER 10.09.<u>2025</u>

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the fixed charges from 07/2024 to 12/2024 as per pre vailing tariff rate (i.e, @ Rs.40).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>October-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
