#### GIST OF THE COMPLAINT:

The complainant consumer The President, Duajhar Pani Panchayat, AT/Po- Duajhar, Ps- Khariar, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 25.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Irrigation supply with CD of 9 KW having consumer no- 9060-0102-0236 under EE, NED, Nuapada.
- 2) The LI point Duajhar Pani Panchayat was damaged due to thundering and lightening so the consumer has not avail the power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (EE, NED, Nuapada) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from December 2010 to April 2024
- 3) Date of supply 27/07/2008
- 4) Category: LT/Irrigation Pumping and Agriculture
- 5) Connected Load 9 KW
- 6) Meter No 10051141
- 7) Installed on March 2024
- 8) CMR: 348 KWH 23/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill

As written version submitted by EE, NED, Nuapada as follows:

• The consumer has complained the billing dues that has been raised from July 2008 to April 2024 and requested for waive off his dues for this above mention period. Dues have been accumulated through provisional billing during this period. As per the office of the JE, LI elect. Section Khariar consumer has availed power supply on dt. 16/04/2024. Consumer is bill stopped in the system from April 2024.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing during supply disconnected period.
- The OP stated that the consumer has complained the billing dues that has been raised from July 2008 to April 2024 without power supply and requested for waive off his dues for this above mention period. Dues have been accumulated through provisional billing during this period.
- As per the office of the JE, LI elect. Section Khariar consumer has availed power supply on dt. 16/04/2024. Consumer is bill stopped in the system from April 2024.
- The JE LI section II Khariar has intimated that the LI was defund from July 2008 to March 2024. As it has been energised and handed over to TPWODL, on dt. 16/04/2024 vide latter no. 92 date-01/08/2024.

# ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

 To withdraw the bill amount excluded the fixed charges from July 2008 to March 2024 as the consumer has not availed the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
